- As of April 1st, 2020 please send all orders to Emtron electronic GmbH only
- As of April 1st, 2020 invoices will be issued by Emtron electronic GmbH only
- All open orders at the time of transition will be processed by Emtron electronic GmbH with reference to the old order numbers. You will merely receive a new order confirmation; no further action is required from your side.
